Article III - Purpose

The business of this Company shall be to engage in: export, import, trade, and any business of its choosing in which a limited liability company is authorized to engage under the laws of the State of Florida.

Article IV - Duration

This Company shall exist perpetually.

Article V - Membership

This Company has at least one member. Additional members may be admitted to the company upon unanimous consent of existing members.

Each member shall have the right to a vote, directly proportional to his/her share of ownership in the Company. All voting will be done solely, with the full knowledge and/or opportunity being granted to all qualified members, to participate in said procedure.

Any member may transfer their interest or membership in this Company, in whole or in part, to any other person, or, entity, subject to the conditions set out in this Article. However the transferee shall only acquire the right to share in any profits/losses, or other compensation, that would have otherwise been credited to the transferor, and in no way acquires any authority or right to participate in the management of the Company or decision making regarding any actions or disposition of the Company or any of its assets.

No member may transfer or otherwise encumber his/her interest or membership in the Company, without first offering said interest or membership to the Company. In the event that the Company fails or refuses to accept said offering, the member may then transfer or encumber his/her interest or membership subject only to the restriction of the right to participate in the management of the Company as stated above.

Article VI - Management

This Company will be managed by a manager or management team. The management of this Company will be conducted within the guidelines set forth by the Florida Limited Liability Act and the terms of this document.
