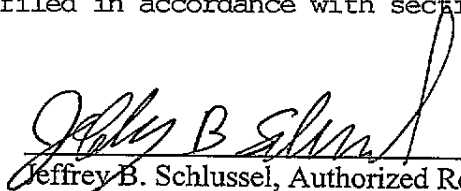
ARTICLE V: Purpose
