OF

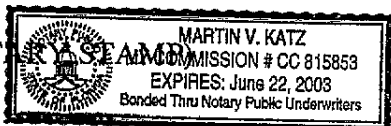


