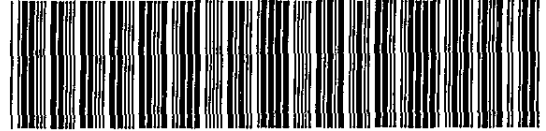

3. The limited liability company has adopted the following amendment to the Articles of


