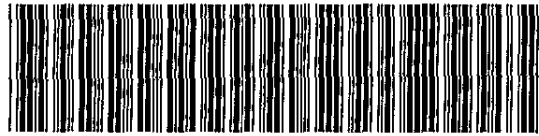

FLORIDA LIMITED LIABILITY COMPANY**


1. The name of the limited liability company is: BP Pines, L.L.C. (the "Company")

7. There are not suits pending against the Company in any court.


