**ARTICLE I  
NAME**

The name of this Limited Liability Company is AQUAGRACE, LLC.

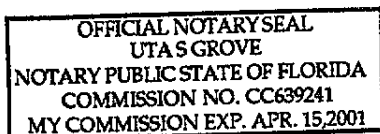

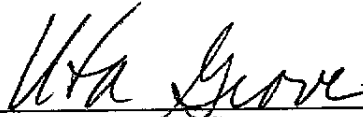
