ARTICLE I - NAME

The name of the limited liability company shall be PRIVATE CLUB LINKS.COM, LLC, ("company").

ARTICLE II - ADDRESS

The company shall be dissolved on the death, bankruptcy, or dissolution of a member or manager, or on the occurrence of any other event that terminates the continued membership of a member in the company, unless the business of the company is continued by a majority vote of the remaining members.

the members for the management of the business and affairs of the company. These regulations may contain any provisions for the regulation and management of the affairs of the company not inconsistent with law or these articles of organization. 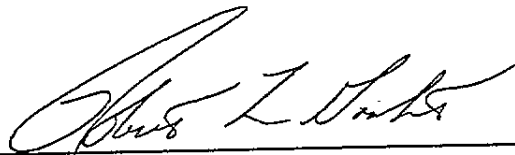

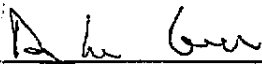
