ARTICLES OF ORGANIZATION OF SERVICIO DE ATENCION AL VIAJERO (SAV) LLC

The undersigned, for the purpose of forming a limited liability company under the laws of Florida, hereby adopts the following Articles of Organization:

Article I Name

The remaining Members of the limited liability company will have the right to continue the business upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a Member or occurrence of any other event which terminates the continued Membership of a Member in this Company. The Company shall terminate upon the consent of all Members or as otherwise previded in accordance with the terms of the Regulations and Operating Agreement.
