ARTICLES OF ORGANIZATION OF SEA GRILL, L.L.C.



ARTICLE I

Name

The name of the limited liability company ("Company") is SEA GRILL, L.L.C.

ARTICLE II

Address

The mailing address of the Company is 1127 Hunters Place, Oldsmar, Florida 34677 and street address of the Company's principal office is: 3253 State Road 584, Palm Harbor. Florida 34684.

ARTICLE III

Duration

The period of duration for the Company is perpetual, beginning on the date that these Articles of Organization are filed by the Florida Department of State.

ARTICLE IV

Registered Agent and Office

The name of the Company's initial registered agent in Florida is John W. Warford. The address of the Company's registered office in Florida is 1127 Hunters Place, Oldsmar, Florida 34677.

ARTICLE V

Management

The Company is to be managed by a manager. The initial manager will serve until the first annual meeting of the members or until the manager's successor is elected and qualified. The initial manager is identified as John W. Warford, whose address is 1127 Hunters Place, Oldsmar, Florida 34677.

ARTICLE VI

Admission of Additional or New Members

Members of the Company have the right to admit new members. Additional or new members may be admitted only on the unanimous written consent of the existing member or members, and the existing member or members shall determine the amount and nature of contributions to be made by the additional or new members at the time those new members admitted.

ARTICLE VII

Continuance of Business

The remaining member or members of the Company have the right to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Company. The business may be continued only on the unanimous written consent of the remaining member or members.

ARTICLE VIII

Additional Provisions

The power to adopt, alter, amend or repeal the regulations of the Company is vested entirely in the managers listed in Article V.


