ARTICLE I - NAME

The name of the limited liability company is GATEWAY/ABSOLUTE VENTURE, L.C. (hereinafter referred to as the "Company").

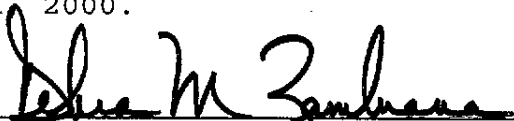
