#### ARTICLES OF ORGANIZATION

OF

#### THE GRUESOME GUMMY COMPANY, L.L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

#### ARTICLE I-NAME 608.407(1)(a)(1998)

## <u>ARTICLE II—DURATION</u> 608.407(1)(b)(1998)

The company shall be dissolved on the death, bankruptey, or dissolution of a member or manager, or on the occurrence of any other event that terminates the continued membership of a member in the company, unless the business of the company is continued by (majority)/(unanimous) vote of all the remaining members.
