ARTICLES OF ORGANIZATION

OF

JAKE'S NATURALS, L.C.

The undersigned Member adopts the following Articles of Organization for the purpose of forming a limited liability company under the Florida Limited Liability Company Act.

ARTICLE I

Name and Principal Place of Business

The name of the limited liability company shall be **Jake's Naturals, L.C.** (the "Company"), and the mailing and street address of the Company's principal office shall be located at 428 Arricola Avenue, St. Augustine, Florida 32084. However, the Members shall have the power and authority to establish branch offices at any other place or places as they may so designate.

ARTICLE II

Nature of Business

The general nature of the business to be transacted by this Company is to engage in any activity or business permitted under the laws of the United States or this State.

ARTICLE III

Duration and Dissolution

- A. The Company shall exist perpetually.
- B. The remaining Members may continue business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a Member, or the occurrence of any other event which terminates the continued Membership of a Member in the Company.

ARTICLE IV

Membership

The Company may have two classes of Membership to be designated Class A and Class B. The relative rights, obligations and preferences in the classes of Membership shall be specified by the Regulations. However, except as specifically provided by the Regulations, only Class A Members shall be entitled to vote to (a) elect a Manager or Managers; (b) continue the business of the Company; (c) admit additional Members; or (d) adopt, alter, amend or repeal the Regulations.

ARTICLE V

Membership Restrictions

Class A Members shall have the right to admit new Members by unanimous consent. The existing Class A Members shall determine the amount and nature of contributions by new Members at the time new Members are admitted.

A Member's interest in the Company may not be sold or otherwise transferred except with the unanimous written consent of all the Class A Members.

ARTICLE VI

Management

This Company shall be managed by two Managers initially. However, the number of Managers may be increased or diminished from time to time by unanimous vote of the Class A Members, but shall never be less than one (1) nor more than three (3).


