**SECOND ARTICLES OF AMENDMENT
OF
SUNDENT CARE, L.L.C.**

1. The Articles of Organization of Sundent Care, L.L.C. (the "Company") were filed on May 4, 2000, and assigned Document Number L00000005113, and the Articles of Amendment of Sundent Care, L.L.C. were filed on June 8, 2000.

2. Pursuant to Florida Statutes Section 605.0202, the Articles of Organization of the Company, as amended, are hereby further amended as follows:

a. Article I is hereby amended to change the name of the Company to Sundent Dental Care, PLLC, and the old Company name shall be replaced with the new name throughout the Articles of Organization of this Company.

b. Pursuant to Florida Statutes Section 621.04, the Members of the Company have elected to bring this Company within the provisions of the Professional Service Corporation and Limited Liability Company Act, Florida Statutes Chapter 621. As such, the Articles of Organization are hereby further amended to add the following:

Article V – Purpose:

The purpose of this Company is to engage in the practice of, and render professional services in, dentistry within the State of Florida and to take all actions that are necessary or proper in connection with that practice.


This Company shall have all powers given professional limited liability companies under Florida Statutes Chapter 621. The period of duration of this Company is perpetual.

3. The foregoing amendments were adopted, to become effective on the date of filing with the office of the Florida Secretary of State, by written unanimous consent of all of the Members entitled to vote on the amendments, in accordance with Florida Statutes Section 605.04073.

4. The Florida Secretary of State is hereby requested to approve and file these Articles of Amendment in accordance with Chapters 605 and 621, Florida Statutes.
