**CERTIFICATE OF FIRST AMENDMENT
OF
ARTICLES OF ORGANIZATION
OF
RRG MARKETING, L.L.C.**

THIS IS TO CERTIFY THAT:

- FIRST: This Certificate amends the Articles of Organization (the "Articles") of RRG Marketing, L.L.C.,
- SECOND: The Articles were filed with the Florida Department of State on May 1, 2000,
- THIRD: Article IV of the Articles previously provided as follows:

***"Article IV
Management***

The Limited Liability Company is to be managed by one or more managers and is, therefore, a manager - managed company."

- FOURTH: Article IV of the Articles is amended to provide as follows:

***"Article IV
Management: Rights, Powers, and Duties***

- 4.1 Management.** *The Company shall be managed by one or more managers and is therefore, a manager-managed company. In the event the Manager is an entity, the entity shall designate a representative to exercise Manager's rights.*
- 4.2 Proxies.** *The Manager's responsibilities shall include the power to appoint proxies to vote the interests in other entities in which the Company holds interests, as well as to make and direct investments on behalf of the Company.*
- 4.3 Liability and Indemnification.**
- 4.3.1** *The Manager shall not be liable, responsible, or accountable, in damages or otherwise, to the Company for any act performed by Manager with respect to Company matters, except for fraud.*
- 4.3.2** *The Company shall indemnify Manager for any act performed by Manager with respect to Company matters, except for fraud."*
