ARTICLE VII. DISSOLUTION OF COMPANY

Upon the death of the founding member, Mark C. Fetherman, all aspects of his membership are to pass to Nora A. Fetherman, spouse of founding member Mark C. Fetherman. Upon the retirement, resignation, expulsion, bankruptcy, or dissolution of a member or upon the occurrence of any other event that terminates the continued membership of a member in the Company, the Company shall be dissolved unless all of the remaining members consent to continue the Company.
