

Pursuant to our representation of JRS Executive Search, LLC, the above-referenced limited liability company was administratively dissolved for failure to timely file its 2002 Annual Report/Uniform Business Report Form. However, neither the company nor any of its officers or directors received from the Florida Department of State the 2002 Annual Report/Uniform Business Report Form to be completed.
