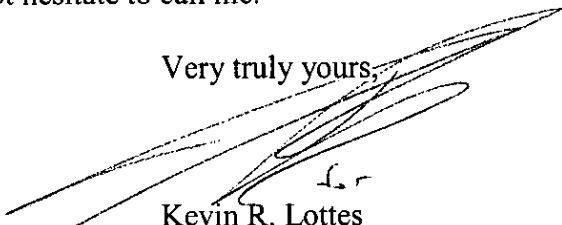
Dear Sirs:

Pursuant to our representation of JRS Executive Search, LLC, the above-referenced limited liability company was administratively dissolved for failure to timely file its 2002 Annual Report/Uniform Business Report Form.
