## ARTICLES OF ORGANIZATION FOR SENATOR 8, LC

The undersigned, as a member of the limited liability company named below, which is hereby organized under the Florida Limited Liability Company Act (hereinafter the Act), adopts the following Articles of Organization (Articles):

- 1. Name. The name of the limited liability company is Senator 8, LC (hereafter Company).

- 6. Additional Capital Contribution of Members. Capital contributions in addition to the initial capital contributed by the members at formation of the Company shall be required in accordance with the Company's Operating Agreement.

- i. That no offer or sale of certificates in the Company shall be made to a nonresident of the State of Florida;
