ARTICLES OF ORGANIZATION OF

ARTICLE VI


MEMBERS' RIGHTS TO CONTINUE BUSINESS

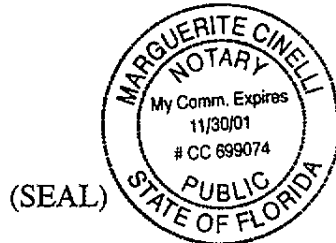

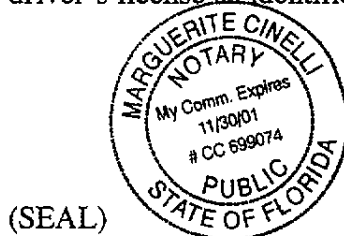


