# ARTICLES OF ORGANIZATION FOR WESTHAVEN HOMES, L.L.C.

### A FLORIDA LIMITED LIABILITY COMPANY

The undersigned as organizers and Members of Westhaven Homes, L.L.C., under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes adopt the following Articles of Organization:

#### ARTICLE I - NAME

The name of the limited liability company is Westhaven Homes, L.L.C.

#### ARTICLE II - PURPOSE AND POWERS
