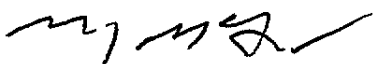

A majority of existing members must approve admission with votes being cast weighted by percentage of ownership, i.e. one percent owned, 1 vote five percent ownership has five votes.

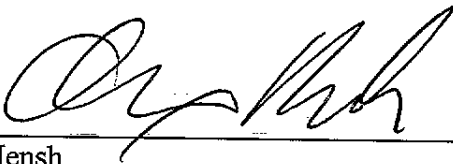
#### **ARTICLE VI – MEMBERS RIGHTS TO CONTINUE BUSINESS:**
