## ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION OF SIMS FAMILY ENTERPRISE, L.L.C.

Pursuant to the provisions of Section 608.411, Florida Statutes, this Florida Limited Liability Company adopts the following Articles of Amendment to its Articles of Organization:

- 1: The name of this Limited Liability Company is Sims Family Enterprise, L.L.C.
- 2. The date of filing of the Articles of Organization was May 12, 2000 and assigned document number L00000005467.
- 3. Article V of the Articles of Organization of the Limited Liability Company is hereby amended in its entirety to read as follows:

## "ARTICLE V
