The date of filing of the Company's Articles of Organization was filed May 10, 2000 under Document No. L00000005551.

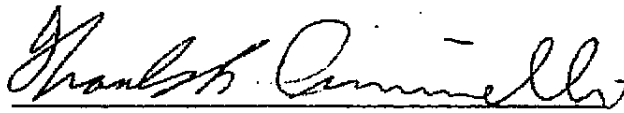
ARTICLE II

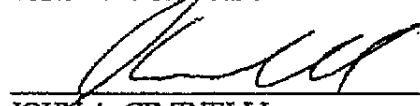
Article I of the Company's Articles of Organization is deleted in its entirety and the following is substituted in its stead:
