## ARTICLES OF ORGANIZATION

## PROFESSIONAL SALTWATER FISHERMAN'S ASSOCIATION LLC

Pursuant to the provisions of the Florida Limited Liability Company Act, the undersigned hereby adopt the following Limited Liability Company Articles of Organization.

## ARTICLE I

#### Name

The name of the limited liability company is **Professional SaltWater Fisherman's**Association LLC (the "Company").

## ARTICLE II

### **Duration**

The Company shall have a duration from the date of organization until December 31, 2050, unless it is dissolved and its affairs wound up prior to that date in accordance with the Florida Limited Liability Company Act (the "Act").

#### ARTICLE III

## **Purposes**

The purposes for which the Company is formed are to provide for a professional, unified membership of saltwater anglers who actively and routinely participate in saltwater fishing tournaments and to provide information access and communication to keep informed such membership of saltwater fishing tournaments, fishing news and other information associated with saltwater fishing and all activities associated therewith, and to engage in any other lawful act or activity for which limited liability companies may be organized pursuant to Act.
