

**ARTICLES OF ORGANIZATION
OF
LAW POINTE, LLC**

The undersigned, being the Organizer of the Limited Liability Company hereby being formed under the Florida Statutes Annotated Sections 608.401 to 608.471, do hereby adopt the following Articles of Organization for the Limited Liability Company:

FIRST: The name of the Limited Liability Company is:

Law Pointe, LLC

SECOND: The latest date on which the Limited Liability Company is to dissolve is December 31, 2050.

THIRD: The Limited Liability Company is organized to engage in and do any lawful act concerning any lawful business, other than banking and insurance, for which a limited liability company may be organized in accordance with the Florida Statutes Annotated Sections 608.401 to 608.471, including all powers and purposes now and hereafter permitted by law to a limited liability company.

FOURTH: The street address of the initial registered office of the Limited Liability Company in Florida is 1111 Kane Concourse, Suite 401, Bay Harbor Islands, Florida 33154, and the name of the initial registered agent of the Limited Liability Company in Florida at that address is Alan Sakowitz.

FIFTH: The mailing address and principal office of the Limited Liability Company is 1111 Kane Concourse, Suite 401, Bay Harbor Islands, Florida 33154.

SIXTH: The Limited Liability Company is to be managed by the Manager. The names and addresses of the initial Manager are: Florida Pointe, Inc., a corporation, having an address at 1111 Kane Concourse, Suite 401, Bay Harbor Islands, Florida 33154

SEVENTH: The total amount of cash (and a description and agreed value of any property other than cash) contributed to the Limited Liability Company, as capital, by the Members is \$1,000.00. The allocations and distributions of the Limited Liability Company shall be made in proportion to the Members' Percentage Interests.

ELEVENTH: The remaining Members of the Limited Liability Company, by the affirmative vote or consent of Members holding a majority of the Members' Percentage Interests (other than the Member who caused the Withdrawal Event), may continue the Limited Liability Company upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member in the Limited Liability Company.

TWELFTH: None of the Members of the Limited Liability Company are liable for payment of any debt, obligation or other liability of the Limited Liability Company.
