**ARTICLES OF ORGANIZATION  
OF  
M B SERVICES OF NAPLES, L.L.C.**

The undersigned, pursuant to §608.407, Florida Statutes, adopts the following Articles of Organization for such limited liability company.

**ARTICLE I – Name**

The name of the limited liability company is M B Services of Naples, L.L.C.

**ARTICLE II – Duration**

The period of duration for the limited liability company shall be perpetual.

**ARTICLE III – Address**

**ARTICLE VI – Admission of Additional Members**

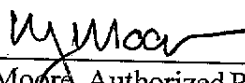

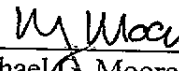
