## ARTICLES OF ORGANIZATION

OF

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby, makes, acknowledges, and files the following Articles of Organization.

#### ARTICLE I--NAME

The name of the limited liability company shall be Marick Investments, LLC ("Company").

#### ARTICLE II--ADDRESS

The mailing address and the street address of the principal office of the Company is 5260 Woodland Lakes Drive, Palm Beach Gardens, FL 33418.

#### ARTICLE III--REGISTERED AGENT

#### ARTICLE IV--MANAGEMENT

The Company shall be managed by a manager in accordance with the operating agreement adopted by the members for the management of the business and affairs of the Company. #### ARTICLE V--MEMBERSHIP RESTRICTIONS

Members shall have the right to admit new members by unanimous consent. Contributions required of new members shall be determined as of the time of admission to the Company.

A member's interest in the Company may not be sold or otherwise transferred except with unanimous written consent of all members.

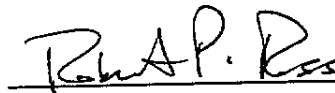
