**ARTICLES OF ORGANIZATION
FOR
FORT WALTON OPEN MRI, L.L.C.**

A FLORIDA LIMITED LIABILITY COMPANY

The undersigned acting as the organizer and a member of FORT WALTON OPEN MRI, L.L.C., under the Florida Limited Liability Company Act, Chapter 608, Fla. Stat., adopts the following Articles of Organization:

**ARTICLE I
NAME**

The name of the limited liability company is FORT WALTON OPEN MRI, L.L.C.

**ARTICLE II
PURPOSE AND POWERS**

A. Purposes. The Company is organized to own and operate an open MRI clinic in Fort Walton Beach, Florida and purposes incident thereto.

B. Powers. The Company shall have and may exercise all powers and rights which a limited liability company may exercise pursuant to Chapter 608, Fla. Stat., as the same may be amended from time to time.

**ARTICLE III
INITIAL REGISTERED AGENT, REGISTERED OFFICE ADDRESS**

**ARTICLE IV
DURATION**

The Company's existence shall commence upon the acceptance of these Articles of Organization by the Secretary of State, and it shall exist perpetually thereafter unless dissolved according to law or the Company's Operating Agreement.

ARTICLE VI

The Company shall admit new members only upon the unanimous written consent of all then existing members of the Company. Any new members admitted shall not become a manager without the unanimous written consent of all then existing members of the Company.

ARTICLE VII
CONTINUATION OF BUSINESS

The Company shall not be dissolved upon the death, retirement, resignation, expulsion, or bankruptcy of a member.

ARTICLE VIII
AMENDMENTS

The Company reserves the right to amend any provision of these Articles of Organization, which amendment shall only be effectuated by the unanimous written approval of all members of the Company.


