ARTICLES OF ORGANIZATION FOR FORT WALTON OPEN MRI, L.L.C.

A FLORIDA LIMITED LIABILITY COMPANY

The undersigned acting as the organizer and a member of FORT WALTON OPEN MRI, L.L.C., under the Florida Limited Liability Company Act, Chapter 608, <u>Fla. Stat.</u>, adopts the following Articles of Organization:

ARTICLE I NAME

The name of the limited liability company is FORT WALTON OPEN MRI, L.L.C.

ARTICLE II PURPOSE AND POWERS

- A. <u>Purposes</u>. The Company is organized to own and operate an open MRI clinic in Fort Walton Beach, Florida and purposes incident thereto.
- B. <u>Powers</u>. The Company shall have and may exercise all powers and rights which a limited liability company may exercise pursuant to Chapter 608, <u>Fla. Stat.</u>, as the same may be amended from time to time.

ARTICLE III INITIAL REGISTERED AGENT, REGISTERED OFFICE ADDRESS

The street address and mailing address of the initial corporate office and initial registered office of this Company is 4423 Duffer Loop, Sebring, Florida 33872, and the name of the initial registered agent of this Company at that address is Keith Freudenberger.

ARTICLE IV DURATION

The Company's existence shall commence upon the acceptance of these Articles of Organization by the Secretary of State, and it shall exist perpetually thereafter unless dissolved according to law or the Company's Operating Agreement.

ARTICLE VIII **AMENDMENTS**

The Company reserves the right to amend any provision of these Articles of Organization, which amendment shall only be effectuated by the unanimous written approval of all members of the Company.
