**WHEREAS**, the name of the company is FORT WALTON OPEN MRI, L.L.C., a Florida limited liability company ("Company"); and

**WHEREAS**, the Company was formed pursuant to the laws of the State of Florida on May 22, 2000 and assigned document number L00000005861; and

**WHEREAS**, the undersigned Company, by and through its Members and pursuant to the provisions of Section 608.411 of the Florida Statutes, unanimously agreed to amend the aforesaid Articles of Organization in the manner hereinafter set forth as of October 27, 2000.

**NOW, THEREFORE**, the undersigned hereby amends the Articles as follows:

1. The Articles of Organization for Fort Walton Open MRI, L.L.C. are hereby amended by adding the following Article IX:

**"ARTICLE IX  
CERTIFICATION"**


