These Articles of Organization shall be effective as of the date of their execution, May 16, 2000.

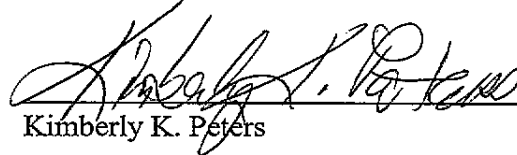

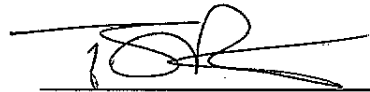
