The purpose for which the Company is organized is to carry on any lawful business, purpose or activity for which a limited liability company may be organized under the laws of the State of Florida.

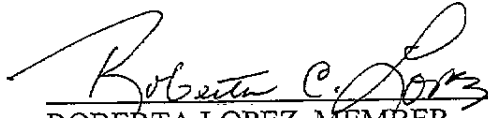
ARTICLE V
