# ARTICLES OF ORGANIZATION OF BLUE TURTLE LLC

# BLUE TURTLE, LLC A LIMITED LIABILITY COMPANY

The undersigned hereby certify that we have associated ourselves together for the purpose of organizing a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges and immunities of limited liability companies for profit.
