ARTICLES OF DISSOLUTION
OF
POPCAB, LLC

Pursuant to the provisions of §608.441 of the Florida Statutes, the undersigned Popcab, LLC, a Florida limited liability company (the "Company"), adopts the following Articles of Dissolution for the purpose of dissolving the Company:

1. The name of the Company is Popcab, LLC;
2. The Company's dissolution is effective upon filing;
3. In exchange for the cancellation of all of the Company's indebtedness to Medcanica, Inc., a Florida corporation ("Medcanica"), the Company transferred all of its assets to Medcanica which, pursuant to §13.01 of the Company's Amended and Restated Operating Agreement dated as of April 27, 2001, is an occurrence of an event which would cause the dissolution of the Company;
4. All debts, obligations and liabilities of the Company have been paid or discharged;
5. After the transfer of all of the Company's assets to Medcanica, the Company had no remaining property and assets to be distributed among its members; and
6. There are no suits pending against the Company.
