FIRST: The name of the Limited Liability Company is: PACIFIC CONSTRUCTION & DESIGN GROUP, L.L.C.




FOURTH: The mailing address and principal office of the Limited Liability Company is 100 So. Orange Avenue, Orlando, Florida 32801.


