ARTICLES OF ORGANIZATION

OF

SAMUEL L. KRETZSCHMAR, JR., D.D.S., P.L.

The undersigned person hereby adopts these Articles of Organization in order to form a professional limited liability company under Chapter 621 of the Florida Statutes.

ARTICLE I - NAME
