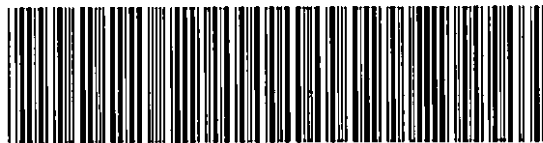

FIRST: This Amended Restated Articles of Organization amends and restates the Articles of Organization of Charlie Grimes Farms, LLC.

SECOND: The original Articles of Organization of Charlie Grimes Farms, LLC were filed with the Florida Department of State on June 5, 2000, and assigned Document Number L00000006424.

THIRD: The Articles of Organization of Charlie Grimes Farms, LLC are hereby amended and restated by deleting the existing Articles of Organization of Charlie Grimes Farms, LLC in its entirety and replacing it with the following:
