### **ARTICLES OF ORGANIZATION**

The undersigned, being a duly authorized representative of a member, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization:

#### **ARTICLE I. NAME**

The name of the limited liability company is HTW Limited Liability Company (the "Company").

#### **ARTICLE II. ADDRESS**

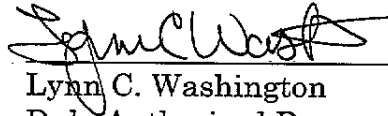

The power to adopt, alter, amend, or repeal the Regulations of the Company shall be vested in the Members of the Company.

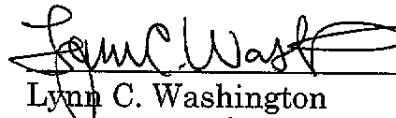
