## ARTICLES OF AMENDMENT

TO

### ARTICLES OF INCORPORATION

OF

Pursuant to Section 607-1006, Florida Statutes, the undersigned limited liability company adopts the following articles of amendment to its articles of incorporation:

FIRST: Article IV - Management shall be amended as follows:

#### ARTICLE IV - MANAGEMENT

Management of this limited liability company is reserved to its members, whose names and addresses are as follows:

SECOND: Article VI - Profits and Losses shall be amended as follows:

#### ARTICLE VI - PROFITS AND LOSSES

Profit Sharing. The members shall be entitled to the net profits arising from the operation of the limited liability company business, that remain after the payment of the expenses of conducting the business activity of the limited liability company. Each member shall be entitled to a distributive share of the profits as follows:

NICOLAS ESCOBAR	15.8%
PIÑESCO LTDA.	25.7%
MEALS DE COLOMBIA	58.5%

The distributive share of the profits shall be determined and paid to the members each year on the anniversary date of the commencement of business of the limited liability company, the month and day of the commencement date being the date of the filing of theses Articles.
