ARTICLE VI -- ADDITIONAL CAPITAL CONTRIBUTIONS

Each member shall make additional capital contributions to the Company as required and in accordance with the regulations of the Company ("Operating Agreement").

ARTICLE VII - ADMISSION OF NEW MEMBERS

These regulations may contain any provisions for the regulation and management of the affairs of the company not inconsistent with law or these articles of organization.
