# ARTICLES OF ORGANIZATION for ELLER BROTHERS INVESTMENTS, LLC

a Florida Limited Liability Company (Sec. 608.407, F.S.)

The undersigned, desiring to form a limited liability company under and pursuant to Florida Statutes Chapter 608 (entitled the Florida Limited Liability Company Act), do hereby adopt the following Articles of Organization for such company:

In the event a new member is added by such amendment, it shall be also signed by the member to be added.
- 9. Regulations of Company. 
