**ARTICLES OF ORGANIZATION OF EVANS BUILDING & DESIGN
LIMITED LIABILITY COMPANY**

The undersigned, being authorized to execute and file these Articles of Organization, hereby certifies that:

ARTICLE I — Name:

The name of the limited liability company (hereinafter referred to as the "Company") is "Evans Building & Design, LLC".

ARTICLE II — Address of LLC and Registered Agent:

2.1 **Principal Office.** The mailing address and street address of the principal office of the Limited Liability Company is 4111 NW 22nd Street, Gainesville, Florida 32605.

2.2 **Relocation.** The Members may from time to time move the principal office to any other address in Florida.

2.3 **Registered Agent.** The initial registered agent of the corporation is BILLY M. BELTZ, JR. and his business office and address is 14103 W. Newberry Road, Newberry, FL 32669.

ARTICLE III — Duration:

The period of duration for the Limited Liability Company shall be perpetual.

ARTICLE IV — Management:

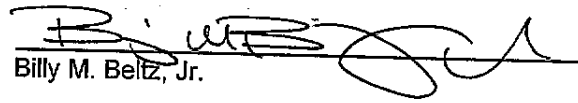
ARTICLE VII — Limitation on Agency Authority of Members

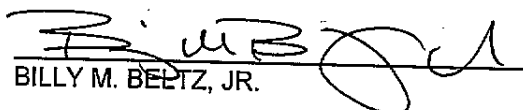

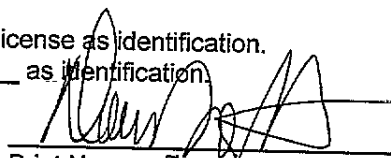
