ARTICLE I. NAME

ARTICLE VI. ADMISSION OF NEW MEMBERS



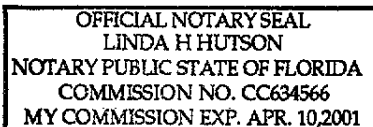


