Management**

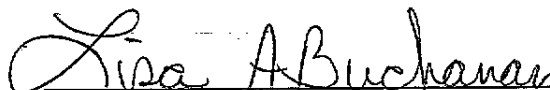
The Limited Liability Company shall be managed by the Members, and all decisions shall be by unanimous consent of the Members.

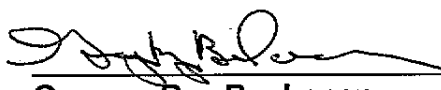
