ARTICLES OF ORGANIZATION

OF

FORTE INVESTMENTS, LLC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I.

NAME

The name of this corporation is FORTE INVESTMENTS, LLC.

ARTICLE II.

ADDRESS

The mailing address and street address of the principal office of the company shall be 325 North Krome Avenue, Homestead, Florida 33030.

ARTICLE III.

PURPOSE

This company is organized for purposes as authorized by Chapter 608 of the Florida Statues and these articles of organization.

ARTICLE IV.

DURATION
