**ARTICLES OF ORGANIZATION  
OF  
EDUCATIONWIZ, LLC**

These Articles of Organization are made for the purpose of organizing a Florida limited liability company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608).

**ARTICLE I - NAME**

The name of the limited liability company is EducationWiz, LLC (the "Company").

**ARTICLE II - ADDRESS**

The mailing address and street address of the principal office of the Company is 931 South Park Road #303, Hollywood, Florida 33021.

**ARTICLE III - DURATION**

The Company is organized for the purpose of organizing and conducting an internet business and transacting any and all other lawful activities and businesses.

**ARTICLE IV  
REGISTERED AGENT; REGISTERED ADDRESS**

**ARTICLE V - MANAGEMENT**

If a member of the Company dies, retires, resigns, is expelled, becomes bankrupt or dissolves, or upon the occurrence of any other event which terminates the continued membership of a member in the Company, the remaining member(s), if any, may, by unanimous written agreement, continue the business of the Company.

**ARTICLE VIII - MISCELLANEOUS**


A. Date of Existence of the Company. The existence of the Company shall commence on the date of filing these Articles of Organization by the Florida Department of State.

B. Transfer of Interest. No member shall have the right to transfer its interest in the Company without the unanimous written agreement of all other member(s), if any. If the non-transferring members do not approve the transfer, the transferee of the interest of the transferring member shall have no right to become a member or to participate in the management of the business and the affairs of the Company. The transferee shall be entitled to receive only the share of profits or other compensation by way of income, and the return of contributions to which the transferring member otherwise would be entitled by virtue of his or her membership.
