ARTICLES OF ORGANIZATION OF EDUCATIONWIZ, LLC

These Articles of Organization are made for the purpose of organizing a Florida limited liability company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608).

ARTICLE I - NAME

The name of the limited liability company is EducationWiz, LLC (the "Company").

<u>ARTICLE II - ADDRESS</u>

The mailing address and street address of the principal office of the Company is 931 South Park Road #303, Hollywood, Florida 33021.

ARTICLE III - DURATION

The Company is organized for the purpose of organizing and conducting an intermet business and transacting any and all other lawful activities and businesses.

ARTICLE IV REGISTERED AGENT; REGISTERED ADDRESS

The name of the initial registered agent of the Company is CT Corporation System. The Florida street address of the initial registered agent of the Company is 1200 South Pine Island Road, Plantation, Florida 33324.

ARTICLE V - MANAGEMENT

ARTICLE VI ADMISSION OF ADDITIONAL MEMBERS

Additional members to the Company may be admitted, but only if all the current members agree to the admission of the additional members and to the terms of admission.

ARTICLE VII MEMBERS RIGHTS TO CONTINUE BUSINESS

If a member of the Company dies, retires, resigns, is expelled, becomes bankrupt or dissolves, or upon the occurrence of any other event which terminates the continued membership of a member in the Company, the remaining member(s), if any, may, by unanimous written agreement, continue the business of the Company.

ARTICLE VIII - MISCELLANEOUS

- A. <u>Date of Existence of the Company.</u> The existence of the Company shall commence on the date of filing these Articles of Organization by the Florida Department of State.
- B. Transfer of Interest. No member shall have the right to transfer its interest in the Company without the unanimous written agreement of all other member(s), if any. If the non-transferring members do not approve the transfer, the transferee of the interest of the transferring member shall have no right to become a member or to participate in the management of the business and the affairs of the Company. The transferee shall be entitled to receive only the share of profits or other compensation by way of income, and the return of contributions to which the transferring member otherwise would be entitled by virtue of his or her membership.
