ARTICLE VIII

DISSOLUTION AND CONTINUANCE

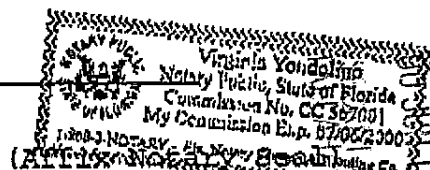
