**ARTICLES OF ORGANIZATION OF CONDESA, LLC
A LIMITED LIABILITY COMPANY**

The undersigned, desiring to form a Limited Liability Company under and pursuant to Section 608.404 of the Limited Liability Act, pursuant to Chapter 608 of the Florida Statutes, of the State of Florida, do hereby certify as follows:

FIRST: The name of said limited liability company shall be the CONDESA, LLC and the mailing address and the street address of the principal office of the limited liability company shall be 19401 East Saint Andrews Drive, Miami, Florida 33015.

SECOND: CONDESA, LLC shall have a perpetual duration from the date of the filing of these Articles of Organization.

THIRD: Copies of the operating agreement and bylaws of the CONDESA, LLC may be obtained from the Managing Member via a written request mailed to 19401 East Saint Andrews Drive, Miami, Florida 33015, which is the place in the State of Florida where the principal office of the company is located.

FOURTH: The purposes for which the CONDESA, LLC is formed are:

- (A) to provide consulting and labor services in the areas of engineering, architecture, economy, business administration and public finances, environmental and computer-related matters.
- (B) to engage in such other lawful acts or activities for which limited liability companies may be formed under Chapter 608 of the Statutes of the State of Florida.

FIFTH: The maximum number of ownership units which CONDESA, LLC is authorized to have outstanding is one hundred (100), all of which shall be identical units, and each of which shall represent the ownership of that percentage of the total units outstanding at any time as is the equivalent of the ratio in which one (1) is the numerator and the total units outstanding is the denominator. Each of the Members herein shall be deemed to own a proportional membership interest of FIFTY (50%) PER-CENT of the total ownership units.

SIXTH: This limited liability company shall be manager-managed and will have two managers, DAVID NAME OROZCO and MONICA PEMBERTY VASQUEZ.
