**ARTICLES OF ORGANIZATION

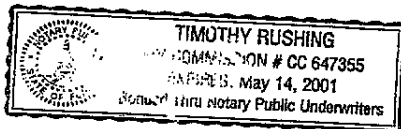
ARTICLE VI - Admission of Additional Members

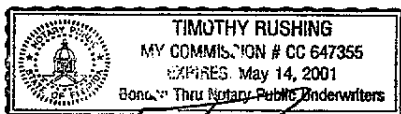

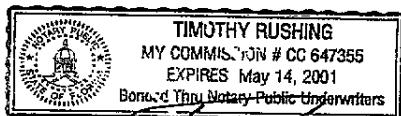
